VISITATION RULES:

- All personal items, excluding a wedding band, engagement ring or religious medals, must be secured in a locker.
- Do not pass any item to an inmate
- For your safety, obey all instructions from a Correction Officer immediately.
- All children must remain seated, within arms length and properly supervised during the visit.
- No visitors, including children are allowed on the inmate side of the barrier.
- You may kiss and hug briefly at the beginning and end of the visit. Other contact is prohibited.
- You will be scanned with a metal detector. Pacemaker wearers must notify an officer so an alternate search method may be used.
- Visitation times are strictly enforced, Please plan to exit the facility at the end of your visit.
- For security purposes, visitation may be interrupted; postponed, re-scheduled or cancelled.
- You must provide a current, un-expired photo ID issued by a state recognized agency.
- If you are on parole or probation, a written statement from the NYS Division of Parole or your Probation Officer is required to permit you to visit.
- Children under 18 years of age must be accompanied by a parent or guardian. Proof of custody is required.
- Appropriateness of clothing shall be the decision of the Correction Staff, Visitors must comply with the following attire restrictions:
 - No tube tops or halter-tops are allowed.
 - No Hooded Items or Coats are allowed.
 - No muscle shirt attire is allowed.
 - No swimsuits or similar attire is allowed.
 - No see-through clothing is allowed.
 - No clothing with obscene, offensive logos, emblems or pictures will be allowed.
 - No Speedos or similar clothing is allowed.
 - No skirts, shorts, pants or other attire that reveal the buttocks or genitalia are allowed.
 - Visitors must wear shoes and a shirt at all times.

Failure to comply with these visitation rules may result in suspension of visitation privileges or your arrest. You are required to comply with these rules and all other directions given by Correction Officers.

I have read the visitation rules as stated and agree to comply with the rules of the Broome County Sheriff's Correctional Facility. I understand that my failure to comply with these rules may limit my ability to visit inmates in custody. I understand that I may be arrested for violations of these rules.

IT IS A CRIME PUNISHABLE AS A CLASS A MISDEMEANOR UNDER THE LAWS OF THE STATE OF NEW YORK, FOR A PERSON, IN AND BY A WRITTEN INSTRUMENT, TO KNOWINGLY MAKE A FALSE STATEMENT, OR TO MAKE A STATEMENT WHICH SUCH PERSON DOES NOT BELIEVE TO BE TRUE.
